NOTIFICATION FORM
FOR RIGHTS VIOLATIONS









The Complaint Notification Form, prepared by the **Human Rights Platform**, allows individuals to report human rights violations in the northern part of Cyprus. It is used to document violations and support subsequent advocacy efforts. Completing the form takes about 5–10 minutes, and all submissions are treated anonymously.

Through this form, you can report human rights violations in the following thematic areas the Human Rights Platform works on:

- Combating Human Trafficking
- LGBTI+ Rights
- Democratic Rights
- Refugee Rights
- Prohibition of Torture and Conditions of Detention
- Note: If your complaint falls outside these areas, please select the 'Other' option and provide details about the specific area of the rights violation.
- Why should I report human rights violations?

Reporting human rights violations is important for ensuring justice, protecting rights, and for advocacy efforts. Complaints help resolve issues and prevent the recurrence of similar violations.

What you need to know before filling out the complaint notification form:

Please read the following information carefully before filling out the complaint notification form:

The complaint notification form can be submitted anonymously. However, if you wish to take the matter further or receive support, either you or the alleged victim must contact us at the Human Rights Platform hotline +90 542 862 00 60, available from 10.00 - 18.00 on weekdays.

Data Privacy and Disclaimer Statement:

Personal information collected within the scope of our project will be kept confidential in accordance with the EU General Data Protection Regulation (GDPR) 2016/679 and relevant local legal texts. By filling out the form, you agree and accept the following data privacy principles.

- Data Collection: We only collect personal information necessary to facilitate your reporting and effectively deliver our services. This may include your name, contact details and specific details about the human rights violation you are reporting. The collected data will also be evaluated within the scope of the Human Rights Violations Reports that the Human Rights Platform regularly monitors and reports.
- Secure Storage: We are committed to protecting your data from unauthorised access, alteration, or disclosure. Your information will be stored on secure servers with limited access.
- Data Usage: Your personal information will be used for the sole purpose of addressing your complaint and providing support. We will not share your data with any third party without your consent, except where required by applicable legal texts.
- Confidentiality: Our team is committed to maintaining the confidentiality of all reported cases, unless disclosure of information is required by relevant legal texts.
- Retention Period: We will retain your data only for as long as necessary to fulfil the purpose for which it was collected, or as required by relevant legal texts, and in any case, not for more than two years.

- **Waiver:** You may withdraw your consent for the continued processing of your personal data at any time by contacting us via the email address provided at the end of this section.
- Third-Party Links: Our platform may contain links to third-party websites or services. Please note that we are not responsible for the privacy practices or content of such sites. We encourage you to review their respective privacy policies before providing any personal information.
- Privacy of Minors: Our platform is not intended for use by minors. We do not knowingly or intentionally collect personal information from minors.

If you believe that we have inadvertently received personal information from a minor, please contact us immediately to request the removal of this data or to ensure it is not used as previously described.

Updates: This data privacy and disclaimer statement may be updated from time to time. Should any changes occur, they will be published on our website. We recommend that you regularly review this statement to stay informed.
